This Form 4 reflects the exercise of warrants ("Warrants") issued by National Association of Securities Dealers, Inc. ("NASD") for the purchase of a total of 147,082 shares of The Nasdaq Stock Market, Inc.'s ("Nasdaq") common stock, par value \$0.01 per share (the "Common Stock"), held by NASD and the sale by NASD of such shares. The Warrants originally were each exercisable for one share of Common Stock in each of four approximately one year consecutive exercise periods, the first, second and, third of which expired at the close of business on June 27, 2003, June 25, 2004 and June 27, 2005, respectively, and the last of which expired at the close of business on June 27, 2006. Processing of the warrant exercises and related sales reported hereby was completed on June 30, 2006. After giving effect to the transactions reported hereby, NASD owns 593,468 shares of Common Stock, a portion of which are underlying Warrants for which exercises were initiated prior to the close of business on June 27, 2006 but for which processing has not been completed.
